- **170. Chairman's Report:** The planning change of use for the flat has been approved. There is a Lowestoft Museum Trustee meeting on 25th January 2020. OBPC will be fighting the decision of the 2 TPOs. This is due to a legacy of mis-management on the ground from District. This will be important to the livelihood of the Leisure Centre.
- **171.** To receive a discussion regarding the table and chairs for the pavilion: Martin Murkett from Tick Solutions will be presenting tables and chairs: On display were 2 tables, one a tilt top and one a fold down. The tilt top is £299, folding table £229. There was numerous of chairs on display. Castors can be removed. Alina £139, without castors £114. Vi £99. The tables would

come in birch. It was proposed to discuss in the Finance Committee. The Council has given delegated approval for the Finance Committee to decide on this item.

OBPC thanked District Councillors Gee and Back for their grant funding money, in aid of the heating in the Museum.
- **174. To receive an update from FoNEP:** Geoff reported that it would be possible to work on the Landspring drain, providing this is done before the end of February, due to nesting birds. They have changed the insurance to volunteer's insurance and public liability. This ended up being cheaper than they originally pay. FoNEP must ensure the signing in and out of the volunteers that work on Thursdays.

Two quotes were received, £8,738.94 and £14,266.15 the third declined to quote. Although, it was thought the quotes were realistic, it was decided to obtain quotes ourselves. **Action Clerk** to obtain a couple of quotes. The Full Council will give delegated authority to the Finance Committee to approve a quote. The decision needs to be made as soon as possible.
