6. Chairman's Report:

We are constantly trying to raise funds for the Charity. Work on the museum will start after Easter and the building will have scaffolding around it while the works are carried out.

7. Public Forum and Public Service Reports:

Cllr. Gee reported that the budget was passed last night, and the new Cllrs had used the plans the previous Cllrs had put in place. The wings were delivered for the Gull Wing bridge and the last few days they have been testing the bridge and it will be ready to be opened soon.

The Council are attending a four-day visit to Felixstowe for a training session.

There will be a meeting with all County Councillors on 25th March, Cllr. Falat will attend representing OBPC to discuss tourist signs for Oulton Broad on each side of the new bridge.

10. To receive the committee reports.

1. Finance report

Council is directed at Item-F6:

(a) The 2022 Tax-Base figure was erroneously used in the 2023-box giving rise to a %-increase of 6.3%, instead of the calculated 5.98%.

the team apologises its inadequacy.

(b) Council will recall that both Suffolk & District were represented at the January meeting, where Suffolk strongly advised OBPC to push for 10%+; this would have put this council into an even more invidious position relative the other ~3% elsewhere (note that Blundeston has agreed 10%).

Council is directed at Item-F10:

(a) The Gazprom[™] account covers a previous period where OBPC was indeed connected to gas (no longer!).

Council is directed at Item-F11.1 (Monckton):

It should be a wish that the Bonds Meadow Group be contacted and asked to represent an exemplar for how to proceed with Monckton.

Council is directed at Item-F11.2 (Neeves):

The sharing-out of huts should perhaps read "Equitably", rather than evenly; with OBPC having raised the issue in the first place and having requested 10-of for the adjacent allotment.

Council is directed at Item-F11.3 (Watersports Windows):

It was noted for this spend ≤£6,000.

Council is directed at Item-F11.4 (Newsletter):

- (a) Martin Hales Design (MHD) has been contacted and asked 3-questions: –
- (i) Price to remedy the omitted 'Royalty' over the last issue ... nil?
- (ii) Royalty pricing for future work going to another printer but using existing file (£100 one-off unlimited)
- (iii) Full quote for complete work to be done by MHD as a 4-page edition; note that including a Survey would increase the order (Design £240 £420; Print of 4k @ £513); this would leave ~£600 for distribution, there being £1,500 in budget for each of 2 newsletters.
- (iv)(b) Cllr FALAT tasked to generate a Parish Questionnaire (Focus Topic suggestions are requested from Cllrs.)

Proposed by Cllr. Ashdown, seconded by Cllr. S Keller, all in favour.

Council is directed at Item-F11.5 (CIL):

(a)as a very rough order-of-cost to install a bus-shelter \rightarrow 3x cost of shelter itself \rightarrow \leq £20k (b)this would leave \sim £6k in the CIL fund, which may almost enable two 5m Low-Play Climbing Walls for Play Areas at say, Bonds Meadow & Kesgrave Field. (costed \sim £3k for 5m and \sim £5k for 10m, including installation); this would be a politically astute move to counter the, "... always NEP ...", perception.

Proposed by Cllr. Bromley, seconded by Cllr. B Keller, all in favour.

Council is directed at Item-F11.6 (Resurfacing):

Additionally, would it be possible to ask contractor to infill alongside the pond, where some soil has slipped? Subject to additional cost, if any.

No meetings so nothing to report, both Michaela and Rebekah are happy. It was brought the Council attention that Tracey Cannon had resigned. New Councillor training is ongoing as not everyone could make the available date.

3. Events & Tourism report

The Spring egg hunt is on the 7th April at 10am, hopefully the weather will be kind. We have had a request for a classic car show which was discussed, and concerns raised over the damage to the grass, it was suggested to use any of the car parks for the display, Cllr. Ashdown will check with ESCC for viability, they will pay around £10.00 per car. Also, a request for the doughnut van to have a summer spot in the park, this was discussed at NEPT and unanimously agreed it was a conflict of interest to the Tenants, so the request was declined.
